From the Minister's Study

It occurs to me that this will be the last annual report I will get to write for Faith United, as I have announced that I will be retiring from active pastoral ministry on June 30, 2024 after almost 17 years of ministry here. That reality has been weighing on me as I realize this is just another of a series of 'lasts' that I will experience this year. The stress of sharing the news with people has receded and is being replaced by a curious mixture of gratitude and sadness. And so, I offer this reflection of the year that was, from the minister's vantage point, with a poignant spirit.

2023 began on a somber note as Faith United was rocked by the loss of four long-time members in quick succession in January. Sadly, there were several more funerals through the year, far exceeding Faith's usual number, making the whole year feel tender with losses. Happily, there were some weddings, a baptism, and the welcoming of several new members to balance the ups and downs of life.

In the spring Faith engaged in a significant conversation about the possibility of creating a small housing development on the back acreage of the church's property. Strong views were shared, both in favour and opposed, and through dialogue, listening, and prayer the decision not to proceed at this time was made. It was a challenging conversation at times, but the congregation came through it with respect and love, as expected.

In the spring we also bid farewell to our long-time office administrator, Stacey Chicoine, as she moved on to a new position at the United Church head office, and we welcomed our new admin Matthew Larcombe.

At the end of May, we had a special afternoon tea for our more senior congregants which was delightful. In September we had a big September Startup event welcoming old friends and new ones for a new season at Faith. Then there was a fall door hanger campaign, the return of just about all our in-person events and practices (like coming forward for communion), and we even celebrated a 100th birthday with our friend Dot.

On the personal front, the big news of 2023 for my family was our kitchen and ensuite renovations (which look fantastic). I did a big piece of work for the 'Region' by chairing the Region's strategic plan creation, but didn't get to finally present it because I was waylaid by Covid in October (an unhappy repeat customer). Although, I made myself feel better by acquiring lots of guitar pedals through the year.

Now, as our attention shifts to the coming year, it will be a momentous one for Faith United as I take my leave and a new era begins. This spring will see a series of conversations and surveys to discern the congregation's hopes and dreams and priorities for the future, as a renewed vision is cast, and the process of searching for a new minister begins. I have every hope that this new vision will be the catalyst for a strong new season of ministry for Faith United, and that the coming years will be filled with faithfulness, outreach, and most importantly love, love, love.

As you read through this annual report you'll see how strong the ministry is here at Faith, because it is so widely shared, and so passionately engaged in. This is a wonderful congregation, and I have been incredibly privileged to have served it. I trust your next minister will feel exactly the same way. Celebrate the year that was, and dare to dream about the years to come, as you enter this year of transition, and always remember, "Surely God is in this place!"

Church Council

In preparation for this report, I reviewed the 2023 Council meeting minutes and am happy to report that we have emerged from the dark cloud of COVID and have in many ways, returned to the church we enjoyed before 2020.

Examples of this can be seen in multiple ways:

- Physically, through changes to our building; such as the replacement of our old monocolour electronic sign with a modern coloured one, to better tell the community about Faith United.
- The kitchen renovations were finally completed and it is now in full use.
- We even upgraded the windows in the older part of the church.

Council also continued to adapt and respond as necessary.

We had to say goodbye to Stacey Chicoine, as she left to start a new full-time position with the United Church of Canada. But we welcomed Matthew Larcombe as our new Office Administrator.

Danny Bathgate joined Council as a Member-At-Large, replacing Michelle Jovel who resigned for family reasons. Thank you, Michelle, for your service.

Council updated the Handbook for Council Members. This was last updated in 2014. Thanks to Shirley Taylor for her leadership and work on this project. The Handbook is available for any Congregant to review and is a great resource to see what work our different committees do. Contact Matt in the office for a copy.

But the greatest change has been in our Programs and Outreach.

Mission & Service and Church Work in Durham exceeded their goals again this past year.

We had another successful well drilling fundraiser with Life Water Canada. A new well will be dug in Haiti. There are families in Haiti that will drink clean water today because of the generosity of the people of Faith United.

The UCW Bazaar returned after the COVID lockdown and was a huge success. Congratulations to Kathleen Pearce and her team.

We erected a Pride Banner in our parking lot and a Pride flag in our entrance way, so everyone can see we are an affirming congregation.

The Door Hanger program distributed 2000 information flyers to homes in Courtice. Thank you to all who distributed the hangers.

Tots on Tuesday and Family Fun Night have seen huge increases in attendance, thanks to some creative advertising by Chair Enid DeCoe. If you want to feel refreshed and invigorated, come out on Tuesday morning or the last Friday of the month and enjoy all of the energy.

This was my last year as Council Chair. Although I'm going to hang around a little while until the next Chair takes over. There are many people I have to thank for their support, encouragement and guidance. Thank you, Council members, for your hard work and dedication. To the Council Executive; Debbie VanLonden, Council Secretary; Diana Chappell, Treasurer; Pat Long, Past Council Chair and Reverend Larry, a special thank you.

Next year will have new challenges for Faith United. We are redefining our Faith Life Story (Visioning) to determine our direction and focus for the next few years. Reverend Larry has announced his retirement. We will have to eventually find a new minister to replace him. And our expenses continue to grow faster then our fundraising. But I am confident that with our faith in each other and in Jesus, we will find our way; for surely God is in this place. Help us notice.

Finance and Administration

Another year in the life of our church has come and gone. We have not fully recovered our impetus but continue to struggle to rise up and restore our full support of our congregation. Although Covid has not completely left us, it appears to have calmed down to a somewhat manageable state of affairs for the majority of the people.

COVID may have shut the physical doors of Faith United, but our Faith Family continued to meet in a hybrid manner via online and in person for the bulk of the year. We met online for learning, coffee, and fellowship on a consistent basis and during the spring, summer and fall months, many of our members worked outdoors maintaining and upgrading our Church gardens and extensive property. Food drives were held monthly to assist in feeding people in need.

We are extremely grateful for the continuing financial generosity of our congregants. Your donations have allowed us to continue to meet our ongoing financial obligations, including programs, staff, property maintenance, insurance, taxes, utilities, technology upgrades and UCC assessment fees as well as multiple capital expenses that include among them the replacement of the roof. A big thank you to the men in our church that have taken on the load of a number of upgrades/repairs/ replacements both inside the building and outside on our property on a regular weekly basis.

The Federal funding for COVID financial support funding was paid back to them as per our original agreement with them for the funding minus the \$10,000 that was forgiven for the timely payback.

COVID continued to be a large factor in precluding most_of our fundraising events, a traditional source of income at Faith. It also prevented the rental of spaces in the church throughout the year, another traditional source of income for the church. Once again, however we want to thank all of you for being so supportive in helping us reach much of our financial goals for outreach in our community and abroad through Mission and Service, Church Work in Durham and Lifewater.

We are prayerfully anticipating a full reopening of our building sometime this year. This will facilitate fundraising and rental of church spaces, which will in turn boost our financial resources. As with all areas in our life, the expenses to maintain our church and do repairs is an ongoing necessity. As such, it would be extremely helpful if members of the congregation could possibly add an additional offering monthly in their givings to aid in maintaining our programs and operations as well as the many outreach activities we fund.

A big thank you is extended to Matthew Larcombe, our church office administrator, Diana Chappell, our Treasurer and Shirley Taylor, our Chairperson. Under their watchful eyes and through their diligent efforts, we have a very precise picture of finances at Faith United.

I cannot reiterate it enough- a huge THANK YOU to our Faith Family, who have continued their very generous support of Faith United. As God shepherds us through this uncertain time, through trust and faith in Him, <u>YOU</u> are engaged in the journey, and we continue to support each other. We pray steadfastly for the good health of our Faith United family, and we are thankful to have returned to in-person worship in 2023.

Over the past 18 months, we have had to invest considerable sums into repairs to the building, some of which were due to the aging of the building and some were upgrades to lower our energy costs. As well, we added some components to the sanctuary audiovisual system to improve our live streaming capacity. The repairs made to the main kitchen were mostly covered by our insurance. The only expense that we had was the deductible of \$500 and the upgrade of the island counter to stainless steel for \$3,955.

We received funding to assist with these costs from special donations, a Faithful Footprints grant and a bequest. The net cost to the church was \$253,645 which was taken from our capital replacement and undesignated investment accounts.

In addition to our capital needs, we also withdrew \$87,402 in 2023 to cover operating shortfalls and to repay \$30,000 of our federal Covid Emergency loan.

¹The asset replacement account holds all donations made to capital expenses.

²The undesignated fund can be used for whatever purpose is required. This is the fund that we have drawn on most heavily in the past two years for both capital and operating needs.

³The designated investment account holds funds that are set aside for a specific purpose such as the former Manse fund which contributes to the minister's salary and M&S donations.

Expenses

We have changed how we record expenses by breaking down some categories so that we can identify the various costs associated with each line item. Some expenses have also been reallocated to other cost centres to reflect more accurately the purpose of an expense.

Gardening Cooperative

This year was successful in so many ways. New members during the summer months were so welcomed and were invaluable as we grew food for the food bank and provided a welcoming feeling to our Church home. We were able to continue our mission to remove invasive species and have made great strides in introducing native plants for the health and well-being of our gardens while providing an opportunity for fellowship and exercise. The front east bed has been renovated to reflect our focus on native plantings to support our pollinators. In addition, a weeping redbud was planted in the front west bed, thereby providing colour, in tandem with the Oakleaf Hydrangeas, through the Spring and Fall in the gardens. In the Spring, we had a prosperous plant sale which enabled us to take on a couple of new projects in the garden while remaining financially independent from the church budget. We planted a native white pine tree in memory of our dear friend, Fred Bull. We raised funds for the new Durham Hospice building project, and we were able to purchase a small illuminated star for the upper garden to brighten up the front of the church during the Christmas season.

Our overall Mission is to provide habitat for native pollinators, mammals, amphibians, etc., in keeping with God's plan for a healthy Earth. All newcomers are welcome. We look forward to starting up again in April 2024.

Through these, it was stated that Designated Income went to Mission and Service, Church Work in Durham, and other outreach like the Lifewater project. These Designated income items have funds flow through without any administration cost. Additional income from rentals and fundraising were very low, given the pandemic situation and the inability to have social gatherings. Operating expenses are projected at deficit for 2023, this includes administration, Payroll, etc. It is hopeful that we will be able to have more fundraising opportunities this year to offset some of the increasing expenses.

Thanks to Dan Bathgate, Gerry Bihun, and Ken Young for letting their names stand for this position. Ballots were distributed to everyone upon entering the church. Choices were indicated and put on the offering plates as they were passed. Rev. Larry explained to the online participants how to vote both in person and online.

Mark L. – Board of Trustees member, Brien Page has moved away. Brien has submitted a letter of resignation, which has been reluctantly accepted. The Board of Trustees have reviewed candidates and would like to recommend Steve Shanks for the Trustee position. Steve has agreed to serve in this position.

Motion: To accept Steve Shanks as a new Trustee.

Financial Matters

Mark L. – Called upon Treasurer Diana Chappell to provide an update on our current financial status.

Diana – Diana presented Faith United's financial situation with graphs as a pictorial representation of the numbers. See the Financial Presentation submitted as part of the meeting minutes for details.

Diana reviewed the following:

- **Operating Income and Expenses** Diana covered the sources of income from envelopes, PAR, Canada Helps online donations, fundraising, rentals and other income such as bequests. It was noted that fundraising was down in large part due to covid restricting the ability to run in person fundraising events. She did note that the years that fundraising was higher seemed to be a result of many different groups offering fundraising events. There has been a drop in the rentals since Covid as outside groups have found other means to hold their gatherings, rather than renting physical spaces. Our nonprofit renters are not charged as much as other renters, so our income is reduced. In some years we managed to receive federal income supplement benefits. Unfortunately, our income is no longer keeping pace with our expenses.
- **Capital Expenses** Over the last 18 months we have had to invest considerable sums into repairs to the building, as it ages. Our total cost of repairs was \$416,631. Special donations towards the roof and air conditioning and a Faithful Footprints grant from the United Church as well as a bequest helped to reduce the cost to \$251,974. This amount had to be drawn from our investments.
- **Current Investment Reserves** We have three investment accounts. The Asset Replacement Account holds all donations made to the capital expenses. The Designated Investment Account holds funds that are set aside for a specific purpose such as M&S donations and the former Manse fund which contributes to the minister's salary. The Undesignated Account funds can be used for whatever purpose is required. We have been drawing funds from both the Asset Replacement fund and the Undesignated fund to cover capital costs of the past 18 months.

Congregational Meeting minutes (continued)

Projected capital needs – A list of potential costs for over the next 5-10 years was generated as a result of church council brainstorming, to try and anticipate things that may arise that need attention, with the potential of an additional expense of about \$220,000.

In summary Diana noted:

Our income is not covering our expenses; There is potential for more capital expenses, as the building ages; Our financial reserves are being depleted; It will be necessary to make careful budget decisions going forward.

Mark L. - The vote was tallied and the new Member-At-Large is Danny Bathgate

The agenda being completed, Mark declared this Congregational Meeting adjourned. The remainder of the service followed the bulletin.

Faces of Faith (*Our on-line congregational Registry*): This document is **pass-word protected**. Pictures of new-comers and updated pictures of others, are taken and uploaded to Faces of Faith regularly. On-line access to FOF has been made more readily negotiable by our Office Administrator who has also reconfigured this file, so that the address, phone number, and email address accompany each picture.

Live streaming: Diana Chappell and Mark Hunter set up the livestream apparatus prior to each service in which it is in use. Audio settings for several microphones, location of the person or group currently 'on camera', insertion of slides or videos, etc. are all managed from the Control Booth at the rear of the sanctuary. This requires two or three personnel, and is provided by a rotation of members of the Committee and others. We were especially pleased to have a high school student [Jonathan Sylvestervich] join us this year.

Over the past year, we upgraded the live streaming computer, replaced the soundboard which failed mid-year as well as the aging lighting system and control panel, and updated other minor components in the sanctuary audiovisual system. We also extended the wifi system throughout the building and set up a Zoom meeting space in the Living Room.

On-line participants are encouraged to tune in via **YouTube** and use the Chat option to communicate with each other. This also allows personnel in the Control Booth to receive feedback from the on-line audience.

Website: Adjustments continue to be made on our website which was redesigned recently by Rev. Larry.

<u>Social Media:</u> Faith United communicates information about our activities on Facebook, Twitter, YouTube. and Instagram. A link to the Sunday service via Livestream is also provided.

Worship & Music

Worship

The primary goal of the Worship Committee is to provide in-person and online, congregants and viewers a meaningful place to grow your relationship with God. We, too, are responsible for:

- planning and overseeing worship services according to the liturgical season and special liturgical Sundays,
- communion preparation and the serving of it,
- finding substitute ministers and musicians,
- reviewing the music program with the music Facilitator
- overseeing the maintenance of the instruments
- overseeing the copyright licensing reporting
- through the chancel and atrium guild adorn the chancel for the liturgical season and any special Sunday
- oversee the decoration and general maintenance of the atrium.

For those who attend in-person, you will notice that we have returned to pre-Covid communion practices, with slight modifications. With the council's approval, the policy concerning who can serve the elements changed to include full members and adherents (a person who regularly contributes to the life and work of the congregation but is not a member or full member). If you feel a nudge to participate in preparing or serving the elements, please speak with any of the worship committee team members. Communion occurs on the first Sunday of every month.

An order of service change occurred by moving the time of announcements from the beginning of service to the offering time. The change reflects Faith's understanding that the life and work of the church is one aspect of our offering. In addition, we were thinking of our online viewers who may appreciate this format better.

Rather than having praise and hymns within the service, we offered a service with all praise songs. This service was well received and occasionally will return. You may have noticed that while Rev. Larry was away, he recorded the message and pastoral prayer while another gave the remainder of the "order of service." We would like to hear your thoughts about this.

As you read this report, we will begin or have begun our Lenten journey as we did during the 2023 AGM. Our Lenten journey culminated with celebrating Ash Wednesday, Palm Sunday, Maundy Thursday, Good Friday, Easter Sunday and Pentecost. As we moved into the long season of ordinary time, we celebrated our affirming ministry, being public, intentional, and explicit towards the inclusion of persons who identify as LGBTQ2S+, sang our hearts out on Hymn Sing Sunday and celebrated the life and work of the church. Rev. Carol Gillard provided pulpit supply during Rev. Larry's July vacation.

Worship and Music (Continued)

After the summer break, we celebrated Creation, Thanksgiving, and Remembrance Day. We finished the calendar year with Lighting the Dark/Blue Christmas Service, two Christmas Eve Services, Family and Carol, Candles and Communion, and Christmas Day. We, too, celebrated with those who participated in the covenanting and baptismal services.

You may notice that our scripture is read either in-person or via video. For those online, this is a way to participate from afar and a lovely way to share your faces with the in-person viewers. We were delighted that Sagid Amaya from Mexico participated in our service this way.

Mission and Service

The Mission and Service Fund Committee (M&S) met the first Thursday of the month, when called by the chair, at the church. Our meetings often were both in person and via zoom.

We endeavoured to keep the congregation informed, aware and involved with the Mission and Service work both locally and globally, via monthly stories. Joyful giving has been evident, with gifts offered to the Mission and Service Fund this year.

Thank you, thank you for your continued support of the Mission and Service Fund. A big thank you also goes out to the United Church Women for their continued support this year.

Our Fundraising efforts included blank note cards depicting summer, winter, and Christmas scenes, many of the photos taken around Faith United church. We also took on the task of creating a 'Meet Us at The Table' cookbook. Two quilts were donated for sale with funds to go to the M&S fund. One of the quilts sold at the bazaar.

As part of our Loonie/Toonie drive, we managed to send to Gifts with Vision – Food for the North, \$1,105.20

Several requests for support of the people of Turkey brought \$680.00 from donations and investments. The Israel-Gaza Disaster appeal raised \$1,000 being donated from the November M&S congregation donations.

The World Development and Relief fund is used to support those suffering from natural disasters and our support this year was \$2,105.00 which included a UCW donation of \$500.00.

The M&S committee participated in the November 19th M&S Sunday 'M&S stories' service with members presenting portions of the service and the message.

This year our Life Water campaign funds were designated for the wells project and totaled \$6,055.55.

The Mission and Service goal in 2023 to support the United Church was \$30,000. We received from donations and fundraising, \$36,270.89 which includes the UCW support of \$3100. Following the talk during the morning service in September about the purpose of the committee, Carolyn and Hazel asked to join us in this ministry. We happily welcome their help and look forward to their membership being approved at the Annual General Meeting.

C. W. I. D. Sunday

On September 24, the committee led the morning worship service, with several members taking part. Speakers from two of our agencies spoke enthusiastically and deeply about the work of their agency and expressed their gratitude to the congregation for their generous support. Marian Timmermans spoke about the new Marigold Hospice being built in Clarington, and Amanda Armbruster shared movingly about the work of the Refuge.

Sheila continues to meet with the CEOs/EDs of various agencies as she is able, to nourish the interpersonal connection with the agencies, as well as to keep our information about the agencies current.

The committee met in October to review the budget and to plan the Christmas outreach program.

The garden for the AIDS Committee of Durham Region (ACDR)

This has been a more difficult year than the first one. The staff with whom we worked to create the garden moved to Ottawa. The young woman who took his place on staff is delightful. However, due in part to the resignation of a few staff and the death of two of the clients who were helping, the support for her has not been there. Sheila has met with the CEO of the agency to discuss the situation and plan this year's garden ministry. In spite of this, every Tuesday, produce was harvested and delivered to the agency, so that it was available to the clients at the agency's Wednesday food bank. The clients were overjoyed to have fresh produce!

The Church Pantry

The church pantry in the basement had been faithfully tended to by Don Winston. However, when Covid hit and the church had to close, we emptied out the pantry, since we had no idea how soon we would return to the building and didn't want the food to go to waste. Recently, we have had a couple of requests from the community, for help with food. The committee discussed this and has decided to reinstate the pantry. Non-perishable food may be left in the foyer. UCW Bazaar

Person power was a bit limited by some members being ill, and some members not being comfortable facing the public. Despite these obvious challenges, we were victorious. Our volunteers included some new members of the congregation and as well we had many family members. This truly is a community event.

Early preparation for this event is essential. Sorting, pricing, cleaning. As our UCW membership has declined, so have the volunteers to help with these tasks. It fell to very few women to make this happen, so I highly recommend that more women step up and offer, and if they cannot do it themselves, perhaps they can recruit family or neighbours to help in their place.

I attempted to reduce or eliminate pinch points entering the different areas and thereby reduce exposure to potential viruses. I had limited success, primarily, I believe, because of lack of support. Additional measures to mitigate COVID exposure included having an ample supply of masks on hand and having multiple hand sanitizers at each station. I would highly recommend that these protocols be continued for <u>all</u> UCW events per Public Health Ontario.

The seemingly endless hours of money counting was done without complaint and we can't thank you enough. Thank you to Cynthia for lending us your e-banking access and helping us to not miss sales.

Enid and Dan. A big thanks for greeting our visitors and making them feel welcome right from the front door. Your contribution is essential to ensuring people come back year after year.

The lunchroom had a new seating plan which included tables for four on one side and tables for 6 (prior was 4) on the opposite side with a larger pathway between them. This was accomplished by moving the silent auction area closer to the stained- glass window by about 30 inches. Being able to seat more people at a time meant shorter waiting time for guests. The food was as wonderful as usual. A big thanks to Linda Walsh and the kitchen elves for keeping us fed and watered.

The Christmas table set the tone for the bazaar as usual. It was bright, well organized, and abundant. Thank you, Beth, and your team. The crafting group, while limited in numbers and time, pumped out an amazing amount of product that dazzled and bedazzled our guests. Well done. They have asked for an advance of \$200 to source product to make their works of art for the next bazaar. The crafting group will be starting up again in February by Kathleen P.

Our baking table was a big success, in no small part to Diane McMahon's experience and hard work. Thank you, Diane, and your team.

The knitting/sewing table was filled with all sorts of wonderful things. Thank you to Donna and your team for keeping it all organized. Some suggestions for new products have been put forward by Libby Roberston for discussion. Please speak with her directly.

The silent auction tables were a big hit again this year. I would like to recommend that additional effort be put into this area by the members of the UCW. In particular, perhaps Community Care could be approached to supply a gift basket as well as additional local businesses.
